This memorandum report presents performance data for the Senior Medicare Patrol (SMP) projects for 2018. The Office of Inspector General (OIG) has collected these data since 1997. In July 2010, the Administration on Aging (AoA), which is part of the Administration for Community Living (ACL), requested that OIG continue to collect and report performance data for the projects to support its efforts to evaluate and improve their performance. OIG reports these performance data on an annual basis. In 2015, ACL substantially changed the performance measures. We made comparisons to data from previous years when possible.

SUMMARY

The SMP projects receive grants from ACL to recruit and train retired professionals and other older adults and community members to prevent, recognize, and report health care fraud, errors, and abuse. These SMP team members then participate in outreach events to help educate Medicare and Medicaid beneficiaries to do the same. In 2018, the 61 projects:

- had 6,935 active team members;
- conducted 26,932 group outreach and education events; and
- had 278,761 individual interactions with, or on behalf of, a Medicare beneficiary.

The projects also had the following results:

\$15,136 in expected Medicare recoveries that were attributable to the projects;

- \$5,734 in expected Medicaid recoveries that were attributable to the projects;
- \$602,063 in cost avoidance on behalf of Medicare, Medicaid, beneficiaries, and others; and
- \$27,689 in total savings to beneficiaries and others.

We note that the projects may not be receiving full credit for recoveries, savings, and cost avoidance attributable to their work. It is not always possible to track referrals to Medicare contractors or law enforcement from beneficiaries who have learned to detect fraud, waste, and abuse from the projects. In addition, the projects are unable to track the potentially substantial savings derived from a sentinel effect, whereby Medicare beneficiaries' scrutiny of their bills reduces fraud and errors.

BACKGROUND

There is 1 SMP project in each of the 50 States, the District of Columbia, Puerto Rico, Guam, and the U.S. Virgin Islands. In 2018, two projects each operated in seven States during different time periods, for a total of 61 projects. In 2018, funding for the program totaled \$18.1 million in Health Care Fraud and Abuse Control Program (HCFAC) funding, including \$142,317 in carryover funds. Of that \$18.1 million, \$2.6 million supported infrastructure, technical assistance, and other SMP program activities, and \$15.6 million went to SMP projects to help beneficiaries prevent, detect, and report Medicare fraud, errors, and abuse. In 2017, funding for the projects totaled \$18.6 million.

Performance Measures

Since the beginning of the program, ACL has modified the performance measures in a number of ways. In 2007, the projects were required to begin measuring "cost avoidance"—the health care expenditures for which Medicare, Medicaid, a beneficiary, or another entity (e.g., a secondary health insurer or a pharmacy) was relieved of responsibility for payment as a result of the projects. In 2012, ACL expanded the performance measures for both Medicare and Medicaid recoveries to account for expected recoveries as well as actual recoveries. This is consistent with the way OIG reports its recoveries.¹

In 2015, ACL changed the other performance measures, with the goal of aligning them more closely with the SMP projects' outcomes. Specifically, ACL reduced the number of performance measures from 21 to 10 by keeping the 5 measures pertaining to recoveries, savings, and cost avoidance and combining or redefining the 16 measures pertaining to volunteer and outreach activities, condensing them into 5 new measures. In addition, ACL no longer requires the projects

to report on the number of media airings and the ways they process complex issues. See Appendix F for a list of the current measures and their definitions.

In 2017, OIG added two new measures that capture additional expected recoveries from cases in which the SMP projects were minimally involved. These new measures—one for Medicare and the other for Medicaid—include actual and expected recoveries that resulted from SMP referrals that validated information in an existing investigation. In contrast, the original two measures on expected recoveries capture recoveries from referrals that led to the opening of an investigation or from meaningful contributions to an existing investigation by an SMP project.

Tracking Systems

ACL maintains a reporting system—the SMP Information and Reporting System (SIRS)—for SMP projects to track and report activities and complaints. While projects commonly resolve complaints on their own, they are expected to refer cases to an investigative agency when necessary. These referrals are also recorded in the system.

METHODOLOGY

We based our review on data reported in SIRS by 61 SMP projects for 2018. In this report, we provide the first 3 years of data for five measures. For these five measures, we reviewed the data for any discrepancies (e.g., if a project reported holding no events but reported a number of people that attended events). For the measures on recoveries, savings, and cost avoidance, we reviewed the projects' documentation in the same manner as in the past. Specifically, we reviewed documentation for expected recoveries and additional expected recoveries of funds for the Medicare and Medicaid programs; documentation for project-attributable savings to beneficiaries and others; and documentation for cost avoidance. Lastly, for the States that have two projects, we combined the data to report State-level totals when appropriate. We provide the results for all 12 performance measures in detail in the appendices.

Standards

We conducted this study in accordance with the *Quality Standards for Inspection and Evaluation* issued by the Council of the Inspectors General on Integrity and Efficiency.

RESULTS

Results for 2018

In 2018, the 61 SMP projects had a total of 6,935 total active team members who conducted a total of 26,932 group outreach and education events, reaching an estimated 1.7 million people. In addition, the projects had 278,761 individual interactions with, or on behalf of, a Medicare beneficiary.

For 2018, the SMP projects reported \$15,136 in expected Medicare recoveries and \$5,734 in expected Medicaid recoveries. Cost avoidance totaled \$602,063, while savings to beneficiaries and others totaled \$27,689. Further, additional Medicare expected recoveries totaled \$11.9 million.² These recoveries came from three projects that validated information for existing cases regarding two home health fraud schemes and one individual physician who provided unnecessary services and falsified records.

In comparison to 2017, the projects reported a 23-percent increase in the number of individual interactions in 2018 (278,761, up from 226,261). Although the number of group outreach and education events remained fairly constant between the 2 years, the projects experienced a decrease in the number of people reached through these channels (1.7 million, down from 1.9 million). In addition, the projects reported significantly higher amounts for cost avoidance (\$602,063, up from \$211,749), while expected Medicare recoveries dropped (\$15,136, down from \$2 million).

Results Since 1997

Since the program's inception 22 years ago, the SMP projects have reported performance data on key measures, including Medicare and Medicaid recoveries; savings to beneficiaries and others; and cost avoidance on behalf of Medicare, Medicaid, beneficiaries, and others. In total, expected recoveries to Medicare and Medicaid attributable to the projects from 1997 through 2018 were \$119.7 million.³ Most of the recoveries resulted from one project's involvement in adjustments to Medicaid claims for individuals entitled to both Medicare and Medicaid.⁴ Total savings to beneficiaries and others were approximately \$7.1 million. Total cost avoidance on behalf of Medicare, Medicare, Medicaid, beneficiaries, and others was \$10 million.

CONCLUSION

The SMP projects receive grants from ACL to recruit and train retired professionals and other older adults and community members to recognize and report instances or patterns of health care fraud. In 2018, the SMP projects had a total of 6,935 total active team members who conducted a total of 26,932 group outreach and education events, reaching an estimated 1.7 million people. Results attributable to their efforts included \$15,136 in expected Medicare recoveries, \$5,734 in expected Medicaid recoveries, \$602,063 in cost avoidance, and \$27,689 in savings to beneficiaries and others. In comparison to 2017, the projects reported a significantly higher amount for cost

avoidance but a significantly lower amount for expected Medicare recoveries. In 2018, the projects also reported \$11.9 million in additional expected Medicare recoveries.

We note that the projects may not be receiving full credit for recoveries, savings, and cost avoidance attributable to their work. It is not always possible to track referrals to Medicare contractors or law enforcement from beneficiaries who have learned to detect fraud, waste, and abuse from the projects. In addition, the projects are unable to track the potentially substantial savings derived from a sentinel effect, whereby Medicare beneficiaries' scrutiny of their bills reduces fraud and errors.

As agreed, we will continue to monitor the projects and will provide ACL with annual summary reports of performance data. This memorandum report is being issued directly in final form because it contains no recommendations.
