This memorandum report presents performance data for the Senior Medicare Patrol (SMP) projects for 2020. The Office of Inspector General (OIG) has collected these data since 1997. In July 2010, the Administration on Aging, which is now part of the Administration for Community Living (ACL), requested that OIG continue to collect and report performance data for the SMP projects to support ACL's efforts to evaluate and improve its performance. OIG reports these performance data on an annual basis.

SUMMARY

The SMP projects receive grants from ACL to recruit and train retired professionals and other older adults and community members to prevent, recognize, and report health care fraud, errors, and abuse. These SMP team members then participate in outreach events to help educate Medicare and Medicaid beneficiaries on the same prevention, recognition, and reporting techniques.

The coronavirus disease 2019 (COVID-19) pandemic presented many challenges for the SMP projects that limited their in-person activities. For example, in lieu of conducting inperson outreach events, the projects conducted live webinars or teleconferences and recorded presentations or public service announcements. In 2020, the 54 projects:

- had 5,720 active team members;
- conducted 9,870 group outreach and education events; and

• had 249,134 individual interactions with, or on behalf of, a Medicare beneficiary.

The projects also had the following results:

- \$16.8 million in expected Medicare recoveries that were attributable to the projects;
- \$53,768 in cost avoidance on behalf of Medicare, Medicaid, beneficiaries, and others;
 and
- \$33,554 in total savings to beneficiaries and others.

We note that the projects may not be receiving full credit for recoveries, savings, and cost avoidance attributable to their work. It is not always possible to track referrals to Medicare contractors or to law enforcement from beneficiaries who have learned to detect fraud, waste, and abuse from the projects. In addition, the projects are unable to track the potentially substantial savings derived from a sentinel effect, whereby Medicare beneficiaries' scrutiny of their bills reduces fraud and errors.

BACKGROUND

There is 1 SMP project in each of the 50 States, the District of Columbia, Puerto Rico, Guam, and the U.S. Virgin Islands. In 2020, funding for the program totaled \$18 million in Health Care Fraud and Abuse Control Program funding. Of that \$18 million, \$2.4 million supported infrastructure, technical assistance, and other SMP program activities, and \$15.6 million went to SMP projects to help beneficiaries prevent, detect, and report Medicare fraud, errors, and abuse. In 2019, funding for the projects totaled \$18.1 million.

Performance Measures

Since the beginning of the program, ACL has modified the performance measures in a number of ways. In 2007, the projects were required to begin measuring "cost avoidance"—the health care expenditures for which Medicare, Medicaid, a beneficiary, or another entity (e.g., a secondary health insurer or a pharmacy) was relieved of responsibility for payment as a result of the projects. In 2012, ACL expanded the performance measures for both Medicare and Medicaid recoveries to

account for expected recoveries as well as actual recoveries. This accounting method is consistent with OIG's accounting of its own recoveries.¹

In 2015, ACL changed the other performance measures, with the goal of aligning them more closely with the SMP projects' outcomes. Specifically, ACL reduced the number of performance

measures from 21 to 10 by keeping the 5 measures pertaining to recoveries, savings, and cost avoidance and combining or redefining the 16 measures pertaining to volunteer and outreach activities, condensing them into 5 new measures. In addition, ACL no longer requires the projects to report on the number of media airings and the ways they process complex issues. See Appendix F for a list of the current measures and their definitions.

In 2017, OIG added two new measures that capture additional expected recoveries from cases in which the SMP projects were minimally involved. These new measures—one for Medicare and the other for Medicaid—include actual and expected recoveries that resulted from SMP referrals that validated information in an existing investigation. In contrast, the original two measures on expected recoveries capture recoveries from referrals from SMP projects that led to the opening of investigations or from meaningful contributions by SMP projects to existing investigations.

This performance year, OIG also looked at the projects' educational outreach activities related to two fraud alerts developed by the SMP program: one related to COVID-19 and one related to fraud schemes involving genetic testing.

Tracking Systems

ACL maintains a reporting system—the SMP Information and Reporting System—for SMP projects to track and report activities and complaints. Although projects commonly resolve complaints on their own, they are expected to refer cases to an investigative agency when necessary. These referrals are also recorded in the system.

METHODOLOGY

We based our review on data reported for 2020 in the SMP Information and Reporting System by 54 SMP projects. In this report, we provide the first 5 years of data for five measures. For these five measures, we reviewed the data for any discrepancies (e.g., if a project reported holding no events but reported a number of people who attended events). For the measures on recoveries, savings, and cost avoidance, we reviewed the projects' documentation in the same manner as in the past. Specifically, we reviewed documentation for expected recoveries and additional expected recoveries of funds for the Medicare and Medicaid programs; documentation for project-attributable savings to beneficiaries and others; and documentation for cost avoidance. We provide the results for all 12 performance measures in detail in the appendices.

Standards

We conducted this study in accordance with the *Quality Standards for Inspection and Evaluation* issued by the Council of the Inspectors General on Integrity and Efficiency.

RESULTS

Results for 2020

The COVID-19 pandemic presented many challenges for the SMP projects that limited their activities. For example, in lieu of conducting in-person outreach events, the projects conducted live webinars or teleconferences and recorded presentations or public service announcements. Some projects reached out to beneficiaries via group emails or telephone calls. As a result, the performance data for 2020 do not reflect a normal year of activities for the projects.

In 2020, the 54 SMP projects had a total of 5,720 active team members who conducted a total of 9,870 group outreach and education events, reaching an estimated 425,103 people. In addition, the projects had 249,134 individual interactions with, or on behalf of, a Medicare beneficiary.

For 2020, the SMP projects reported \$16.8 million in expected Medicare recoveries. Over half of these recoveries came from one project that uncovered a fraud scheme in which a provider paid beneficiaries to receive home health services that were never rendered. The provider then submitted fraudulent claims to Medicare for millions of dollars while also receiving illegal kickback payments from the home health agencies. The provider was sentenced and ordered to pay a total of \$9.5 million in restitution and forfeitures. Another project reported nearly \$5 million in expected Medicare recoveries after uncovering multiple fraud schemes Statewide that involved enrolling beneficiaries in medically unnecessary hospice services. These services were often provided against the beneficiaries' wishes, and at times, interfered with their proper medical care and medications. In addition, cost avoidance in 2020 totaled \$53,768, while savings to beneficiaries and others totaled \$33,554 for all SMP projects.

In addition, the SMP program released a consumer fraud alert on COVID-19 in 2020.² The alert warns beneficiaries about potential fraud schemes involving COVID-19 vaccines and treatments. It advises beneficiaries to be suspicious of strangers offering free COVID-19 testing, supplies, treatments, or vaccines. The alert also advises beneficiaries to be cautious about sharing their personal information, including their Medicare identification number, because this information can be used in fraud schemes. The SMP projects conducted 350 group education events covering COVID-19 fraud issues in 2020, reaching a total of 11,775 people. In addition, they conducted 578 instances of media outreach on this topic, reaching 14.8 million people.

The SMP COVID-19 Fraud Alert

The SMP program produced an alert that provides information about potential scams related to COVID-19 and advises beneficiaries on actions they can take to avoid becoming a victim of such scams. Examples of advice provided in the alert include:

- Be suspicious of anyone going door-to-door to offer free COVID-19 testing, supplies, treatments, or vaccines
- Beware of providers offering other products, treatments, or medicines to prevent the virus. Check with your health care provider before paying for or receiving any COVID-19-related treatment.
- Photos of COVID-19 vaccination cards should not be shared on social media.

The SMP program also continued from 2019 its educational outreach on fraud schemes involving genetic testing.³ Its fraud alert on genetic testing advises beneficiaries to be suspicious of strangers who offer free genetic tests. The alert also cautions beneficiaries about sharing personal information that can be used fraudulently. The SMP projects conducted 641 group education events covering genetic testing fraud issues in 2020; these events reached 24,443 people. In addition, they conducted 102 instances of media outreach on this topic, reaching 850,374 people.

Because of the COVID-19 pandemic, the SMP projects were not able to conduct in-person outreach events and face-to-face individual interactions as they have done in the past. As a result, the projects reported for 2020 a decrease compared to 2019 in the number of group outreach and education events; the number of people reached through these events; and the number of individual interactions. However, the projects reported significantly higher amounts of Medicare recoveries, which increased from \$2.4 million in 2019 to \$16.8 million in 2020. The

majority of these recoveries were the result of investigations that were resolved in 2020 but began several years prior.

Results Since 1997

Since the program's inception 24 years ago, the SMP projects have reported performance data on key measures, including Medicare and Medicaid recoveries; savings to beneficiaries and others; and cost avoidance on behalf of Medicare, Medicaid, beneficiaries, and others. In total, expected recoveries to Medicare and Medicaid attributable to the projects from 1997 through 2020 were \$138.9 million.⁴ Most of the recoveries resulted from one project's involvement in adjustments to Medicaid claims for individuals entitled to both Medicare and Medicaid.⁵ Total savings to beneficiaries and others were approximately \$7.2 million. Total cost avoidance on behalf of Medicare, Medicaid, beneficiaries, and others was \$10.2 million.

Other SMP Activities

As part of a partnership with OIG, the SMP program identifies potential fraud schemes. The SMP program provides OIG with reports, referred to as Special Notifications, intended to provide timely information on emerging fraud schemes that have been identified by the SMP projects. In 2020, the SMP program provided 42 special notifications to OIG. These notifications focused on fraud schemes involving COVID-19 testing and vaccines; opioids; hospice services; drug prescribing; durable medical equipment; genetic testing; and other topics.

CONCLUSION

The SMP projects receive grants from ACL to recruit and train retired professionals and other older adults and community members to recognize and report instances or patterns of health care fraud. In 2020, the COVID-19 pandemic presented many challenges for the SMP projects that limited their in-person activities. As a result, the performance data for 2020 do not reflect a normal year of activities for the projects.

In 2020, the SMP projects had a total of 5,720 active team members who conducted a total of 9,870 group outreach and education events, reaching an estimated 425,103 people. Results attributable to the SMP projects' efforts included \$16.8 million in expected Medicare recoveries, \$53,768 in cost avoidance, and \$33,554 in savings to beneficiaries and others. In comparison to 2019, the projects reported a significantly higher amount for Medicare recoveries. The majority of these recoveries were the result of investigations that were resolved in 2020 but began several years prior.

In addition, the projects are unable to track the potentially substantial savings derived from a sentinel effect, whereby Medicare beneficiaries' scrutiny of their bills reduces fraud and errors.

As agreed, we will continue to monitor the projects and will provide ACL with annual summary reports of performance data.
